CIRCULAR

The Directors / Heads of the University Departments / Centres, the Principal, Sir J.J. College of Architecture, Principals of the Affiliated Colleges /Recognized Institutes, the Librarian, University Library, the warden of University Hostel, the Officers in charge of the different sections/Units in the Registrar's Office, are hereby informed that the University Grants Commission has issued the Regulations, 2009 on curbing the menace of ragging in Higher Educational Institutions, 2009 as per the directions of Hon'ble Supreme Court (Copy enclosed).

The said regulations have been circulated* to the Directors/Principals* of the affiliated Colleges for information and necessary action vide Circular No. CONCOL/286 of 2009 dated 23rd July, 2009.

As per the regulations of University Grants Commission, every University has to constitute a body to be known as 'Monitoring Cell on Ragging'.

Considering the need of Monitoring Cell in the University, it is hereby informed that the Monitoring Cell on ragging has been constituted under the Chairmanship of Director, Board of College and University Development, University of Mumbai.

The Head, University Department of Applied Psychology is also directed to make available the services of professional counsellors before commencement of the academic session for the purpose of offering Counseling to freshers and other students after commencement of academic year as per the provision of 6.1 (ii) of the UGC Regulations 2009 which shall coordinate with the affiliated colleges and institutions under the domain of the University to achieve the objectives of these Regulations; and the Monitoring Cell shall call for reports from the Heads of institutions in regard to the activities of the Anti-Ragging Squads, and the Monitoring Cells at the institutions, and it shall also keep itself abreast of the decisions of the District level Anti-Ragging Committee headed by the District Magistrate.

As per the provision of 6.4 (b) of the said Regulation, the wardens of all the University Hostels are to be made accessible at all hours on telephone and other modes of communications and for the purpose the warden shall be provided with a Mobile phone by the institution, the number of which shall be publicised among all students residing in the hostels and the chairman of the Monitoring Cell of the University.

They are, therefore, requested to submit the reports in regard to the activities of the Anti Ragging Squads to the Director, Board of College and University Development and Assistant Registrar Academic Planning & Development Unit, Room No.132 University Buildings, Fort, Mumbai – 400 032.
